INVITATION TO BID

SYNTHETIC TURF FIELD OVERLAY PROJECT

The School Committee of Bridgewater Raynham Regional Schools as Awarding Authority, invites sealed bids for the replacement of the Synthetic Turf Field at Bridgewater Raynham High School Stadium located at 415 Center Street, Bridgewater MA 02324. A bid form is included in the Bid documents. Bids shall be in accordance with Contract Documents dated June 9, 2021. The Project consists of the preparation and installation of the following:

- i. General Earthwork and Erosion Control
- ii. Athletic Field Subbase Repair
- iii. Field Curb Repair
- iv. Field Levelling
- v. Synthetic Turf & Installation

Bid procedures and award of Contract are subject to the provisions of Massachusetts General Laws (MGL), Chapter 30B, §39M; applicable sections of MGL Chapter 30.

If any changes are made to this Invitation to Bid, an addendum will be issued. Addenda will be emailed to all bidders on record as having picked up the IFB. It is anticipated that the Project will commence upon a Notice to Proceed issued by the Awarding Authority.

Contract Period shall be from June 30 to August 17, 2021. Bid Forms and Contract Documents will be available by email from the Bridgewater Raynham Regional School District. Please contact Kathleen Macedo at kmacedo@bridge-rayn.org.

A non- mandatory pre-bid conference will be held on **Monday June 14, 2021 at 10:30am** local time at the Project location. Interested parties are to meet at the site for a walk through at the Bridgewater Raynham Regional High School Stadium at 415 Center Street, Bridgewater, MA 02324.
